The board (the “**Board**”) of directors (the “**Directors**”) of Precious Dragon Technology Holdings Limited (the “**Company**”) is pleased to announce that all the proposed resolutions as set out in the notice of annual general meeting of the Company dated 24 April 2023 (the “**Resolution(s)**”) were duly passed by the shareholders of the Company (the “**Shareholders**”) by way of poll at the annual general meeting of the Company held on 19 May 2023 (the “**AGM**”).

As at the date of the AGM, the total number of issued ordinary shares of the Company (the “**Share(s)**”) was 233,917,250 Shares. None of the Shareholders were required under the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited to abstain from voting at the AGM. Accordingly, there were a total of 233,917,250 Shares, representing the entire issued shares of the Company, entitling the Shareholders to attend and vote for or against the Resolutions at the AGM. None of the Shareholders were entitled to attend and abstain from voting in favour of the Resolutions. None of the Shareholders had indicated in the circular of the Company dated 24 April 2023 their intention to vote against or abstain from voting on the Resolutions at the AGM.

Tricor Investor Services Limited, the Company’s branch share registrar and transfer office in Hong Kong, was appointed as the scrutineer at the AGM for the purpose of vote-taking.
